

NBRA COVID-19 RE-OPENING MODEL

The New Brighton Residents Association has worked closely within the guidelines established by the Alberta Government, AHS and the City of Calgary to develop a re-opening model for the NBRA Clubhouse & Amenities. Extra precautions and safety measures will be implemented to ensure the safety of our community, neighbours and employees.

Although firm dates cannot be confirmed until released by our governing bodies, the following model provides a tentative timeline and insight into the phases of re-opening the NBRA Clubhouse and Amenities. Our gradual and cautious approach was designed with everyone's safety top of mind.

We greatly appreciate your continued support and patience as we work through this global pandemic together to ensure that you and your loved ones can safely return to the NBRA. PHASE 1



Park Play 1

NBRA Park Access

- Daily, 10am-8pm
- Open Amenities:
 - Green Space
 - Playground
 - Basketball (household only)
 - Ball Hockey (household only)
 - Tennis Courts (singles)
- Skate Room Washrooms

Outdoor Programs

- Child & Adult (contactless)
- Max 8/class

Limitations

- Facility remains closed
- Residents only (no guests)
- Physical distancing required
- Must be 16+ unsupervised
- Max 50 capacity
- Group sizes less than 15
- No drinking fountain access
- Mandatory on arrival:
 - Health assessment
 - Temperature check
 - Mandatory hand wash
 - Equipment sanitization

PHASE 2

NBRA Park Access

- Daily, 10am-8pm
- Phase 1, plus:
 - Outdoor Fitness Equipment (must clean after use)
 - Picnic table & benches

Outdoor Programs

- Mini Outdoor Camps
- Max 8/class

Limitations

- Facility remains closed
- Residents only (no guests)
- Physical distancing required
- Must be 16+ unsupervised
- Max 50 capacity
- No drinking fountain access
- Mandatory on arrival:
 - Health assessment
 - Temperature check
 - Mandatory hand wash
 - Equipment sanitization

PHASE 3



Doors Open

Tentative Date:
*August 28, 2020

NBRA Park Access

- Daily, 9am-8pm
- Phase 1 & 2, plus:
 - Tennis (doubles)
 - Basketball (less than 8)
 - Ball Hockey (less than 8)
 - Volleyball (less than 8)*
 - Sandpit (6 children max)*
 - Splash Park (40 children)*
- *If permitted by AHS.

Clubhouse Building

- Administration Office
- Tool Shed
- Clubhouse Canteen
- Fountain & Vending Machine
- Fall Programs (max 10)
- Facility Rentals/Leases (with capacity restrictions)

Limitations

- Residents (2 guests/property)
- Physical distancing required
- Must be 16+ unsupervised
- Max 150 capacity
- Group sizes less than 20
- Mandatory hand wash

PHASE 4

NBRA Park Access

- Hours & rules resume to those of pre-closure

Clubhouse Building

- Facility Rentals/Leases (some restrictions may still apply)
- Winter Programs (regular program capacity)
- Special Events (with restrictions)

Limitations

- Resume to those of pre-closure

NBRA COVID-19 RE-OPENING MODEL PHASE DETAILS



- During phase 1, the NBRA Clubhouse remains closed with limited access to specific amenities within the park from 10am-8pm, daily.
- All visitors must have their temperature taken with a contactless infrared thermometer, complete a quick health assessment and wash their hands upon arrival at the check-in tent.
- To increase availability for residents, non-resident guests are **not** permitted in phase 1&2.
- To ensure that the required physical distancing of 2 meters is maintained at all times, only 50 visitors are permitted within the park gates during this phase. All visitors under the age of 16 must be accompanied by an adult.
- The amenities made available during this phase are those where proper physical distancing is possible, including: green space, the playground and the tennis courts. The tennis courts are for single play only, unless players on a court are from the same household. The basketball courts and ball hockey are also available for use by members of the same household at a time. A 30 minute courtesy rule applies to all amenities. Visitors must bring their own equipment, and sanitize with the provided supplies upon arrival.
- Access will be permitted to the washroom located within the skate change room, which will be cleaned on an hourly basis by the NBRA team. When using the washroom, visitors are reminded to minimize touch-points and wash their hands immediately after use.



- During phase 2, the NBRA Clubhouse remains closed with limited access to specific amenities within the park from 10am-8pm, daily.
- All of the limitations and procedures described in phase 1, also apply in phase 2.
- In addition to the available park amenities in phase 1; the outdoor fitness equipment, picnic tables and benches will now be useable.
- Visitors must sanitize the fitness equipment, picnic tables and benches after use with the supplies provided at the check-in tent.
- Patrons are reminded that although access is permitted to the washroom located in the skate change room, the vending machine and water fountain cannot be used during either phase 1 of phase 2.

Outdoor Recreation Programs

- During phase 1 & 2, the NBRA will offer outdoor recreation programs for both children and adults.
- All programs will be contactless to ensure that physical distancing requirements are maintained at all times.
- NBRA instructors will work within the guidelines provided by AHS, to ensure the safe delivery of all outdoor programs.

- During phase 3, the NBRA Clubhouse will open its doors, in addition to the limited access of specific amenities from 9am-8pm, daily.
- The volleyball court, sandpit and splash park will now open with the following restrictions, pending permission from AHS:
 - Volleyball: limited to 8 players max.
 - Sandpit: limited to 6 children max.
 - Splash Park: limited to 40 children max.
- Double play tennis will now be permitted.
- Basketball courts and ball hockey will increase to a maximum of 8 players each.
- Residents are now permitted to bring up to 2 non-resident guests per household.
- Physical distancing rules and age restrictions still apply.
- Opening additional amenities increases the total capacity within park gates to 150 visitors.
- Only handwashing will be required upon arrival.

Clubhouse Facility

- The NBRA administrative office will be open from 9am-8pm, daily to offer the following:
 - Administrative services
 - Clubhouse Canteen
 - New Brighton Tool Shed
- Water fountain & vending machine accessible.
- Fall programs will be available for registration with maximum class size of 10 participants.
- Facility rentals will be available for groups of 50 or less (does not impact total park capacity).



- The NBRA Clubhouse and park hours of operation will resume to 9am-10pm, daily.
- The NBRA Clubhouse rules will resume to those existing prior to closure. Please click [HERE](#) for a complete list.

Minimal Limitations

- Facility rentals/leases will be available for group sizes as recommended by governing bodies.
- Winter programs will be available with restrictions as recommended by governing bodies.
- Special events numbers may be reduced, as required by governing bodies.
