NBRA RULES & REGULATIONS

SPLASH PARK

- People must come out of the water immediately when potentially hazardous conditions exist, such as lightning, high winds, and storms.
- Infants must wear bathing suits and/or a water diaper.
- No food, drink, gravel, sand, garbage, etc. is allowed in the water park.
- All users are urged to act in a safe manner. You are RESPONSIBLE and ACCOUNTABLE for all actions.
- Absolutely NO alcohol, smoking, vaping or chewing tobacco is permitted in the Facility Park or Amenities.

EQUIPMENT RENTALS

- Members wishing to sign out equipment must leave their New Brighton Club card at the office, which will be returned to them upon return of the equipment.
- All equipment must be returned 30 minutes prior to the office closing at 10pm.
- Any equipment that is damaged or unsafe should be returned to the office immediately.
- Damage or loss of equipment will result in a fee to be paid immediately to the NBRA.

TENNIS COURTS

- Tennis courts are to be used for tennis only.
- Soft-soled court shoes are to be used.
- Chairs and other hard objects are not permitted on the courts.
- The courts are available on a first come, first serve basis.
- Use of the courts is to be restricted to 30-minute periods during busy times, except if a formal instruction program is scheduled.
- Proper tennis etiquette should prevail to resolve disputes.

VOLLEYBALL COURT

- The court is to be restricted to 30-minute periods during busy times, except if a formal instruction program is scheduled
- The court is available on a first come, first serve basis.
- Proper etiquette should prevail to resolve disputes.
- The volleyball court is designed for volleyball use, which takes precedence over all other activities. After 4pm, daily, the volleyball court is restricted to volleyball use only.

HOCKEY RINK

- No food or drink (except water in closed non glass containers) allowed at any time.
- Anyone found damaging or vandalizing NBRA property may be required to make full restitution to the NBRA.
- Please use the garbage & recyclable bins provided, keep the park tidy.
- The NBRA does not provide any supervision for Facility/Park use. Parents or guardians are responsible for their children under the age of twelve (12) at all times. Please watch your children to ensure they are acting in a safe and cooperative manner.
- The NBRA staff have full authority to evict any person who displays unacceptable behavior, including physical or verbal abuse of any kind. Depending on severity, patrons may be banned from the site for an extended period of time and police may be contacted.

GENERAL RULES

- The New Brighton Club does not provide supervision for park use. Guardians are responsible for their children at all times. Members and guests use the park facilities at their own risk.
- Members MUST have a valid New Brighton Club card in order to enter the park.
- Bicycles, scooters, skateboards, roller-blades, and hover-boards are not permitted in the park, hockey/pleasure rink (water park), walkways or sidewalks.
- With the exception of Seeing Eye dogs, animals are not permitted in the park.
- Alcoholic beverages and glass containers of any contents are not permitted in the facility.
- Open fires are not permitted.
